## 5. Updates on Baldock Expansion

On going concerns raised about Ashwell Road from the new proposed roundabout becoming a Greenway i.e. there will be no vehicles allowed into Baldock from this point. This will mean for Bygrave and Ashwell we will have to turn left onto the new road and join the roundabout at the A505 and Royston Road Junction. At peak times Bygrave and Ashwell will be joining the new estate traffic (from 3000 dwellings) to enter the new road. In addition to go to Baldock down the Royston Road will mean that we will encounter all the HGVs and vans servicing the expanded industrial area. • It is also proposed that under the railway bridge there will be single line traffic both ways to allow sufficient room to install a cycle track. This single lane will be operated from another set of traffic lights aligned with the ones at the junction of Whitehouse Street. These two sets of lights may cause holdups if not aligned properly • It is not intended to increase car parking at the station. If one lives 2miles or less one is expected to cycle or walk • It is proposed that there will be no left turn at the filter from Whitehorse Street into the A507 Great North Road preventing vehicles to get to the station or return from Tesco's from town. Instead, the route will be via South Road up to the Buntingford Road and then straight across at the Whitehorse Street traffic lights.

• There is a possibility that the Surgery may be moved to another location so parking may become an issue if parking is not allowed.

20mph speed limit requested and designated green spaces. To keep Bygrave village separate strongly requested.

Public meeting will be arranged and the date and time will be advertised.

## 6. Update on Solar Farm

Planning Application has been heard by NHDC and they voted to for the Solar farm to go ahead. This is incredibly disappointing.

The Baldock Bygrave Action Group have made representations to the District council and will continue to escalate the matters of the lack of consistency with the full support of Bygrave Parish Council.

Bygrave Parish Council is in favour of a solar farm but not on the site put forward by PACE the developer on land immediately adjacent the upper village and encompassing the last dwellings.

PACE have offered £5,000 to the village to ease some of the burden which is a very small amount and not comparable to other sites, negotiations will continue.

A meeting has been requested with MP Chris Hinchcliffe

The Parish Council extended their thanks to James and Julie for all their hard work with the BAG.

## 7. Update on Bus shelter renovation

Thanks were given to Cllr Whittle and volunteers who have done an amazing job of renovating the bus shelter in the lower village. Work will commence on the top village bus shelter; it was noted that it was not in great repair and was sinking so when suitable grants become available a working group will be formed in order to apply to replace it. To paint and tidy in the meantime.

## 8. To look for funding options for Defibrillator for upper village

Thanks to Liz Whittle for all her hard work in obtaining donations and grants which has led to the installation of a Defibrillator in the lower village.

The BHF funding opens in October so an application will be made to see if can obtain funding for the top village to have this facility.

A reminder that Defib training is Friday 20<sup>th</sup> Sept 6pm to 8pm at Baldock community centre.

9. Meeting with Urban and Civic re roads

A meeting is being arranged.

#### 10. Width restrictions in Ashwell Road

Cllr Hills met with Highways to look at options, chicanes were thought to be the best option, but the locations proposed were too close to peoples drives so have raised that with them for another draft.

## 11. Farrs festival plans

These continue to be planned and residents are asked to feed any complaints to the number on the letter so they can be dealt with. The Parsh council is waiting for the licencing dept to speak to them regarding the granting of the licences and will be asking them to fully review the licence.

## 12. Local Footpaths

Cllr Whittle will report the overgrown footpaths to the Council for some maintenance.
